Additionally, the panel will focus on capital market integration, highlighting the practical steps that can attract global investors and increase capital flows between the two regions."

"As capital markets globalize and become more interconnected, regulatory coordination plays a critical role in ensuring stability, transparency, and investor confidence. This panel convenes leaders from Saudi Arabia and Hong Kong's regulatory and monetary institutions to discuss how deeper alignment is enabling practical, cross-border outcomes - such as recent ETF cross-listings and joint efforts to advance asset and wealth management.

The discussion will focus on the tools, dialogues, and frameworks that support regulatory convergence, including licensing, product approvals, supervision, and investor protection. It will also explore how these collaborations are facilitating new corridors for capital flows between the Middle East and Asia, and laying the groundwork for long-term integration."

The conversation will also examine how deepening regional collaboration - particularly between Hong Kong and Saudi Arabia - is unlocking new opportunities for cross-border capital flows and long-term investor confidence."

"This panel will spotlight leading regional corporates operating at the intersection of energy, infrastructure, and industrial transformation - sectors central to long-term economic growth and capital deployment. The discussion will explore how these firms are leveraging public listings, strategic partnerships, and international capital flows to scale operations, execute regional investments, and meet the expectations of a global investor base. Panelists will also share perspectives on transparency, investor engagement, and financing strategies in today's evolving market environment."

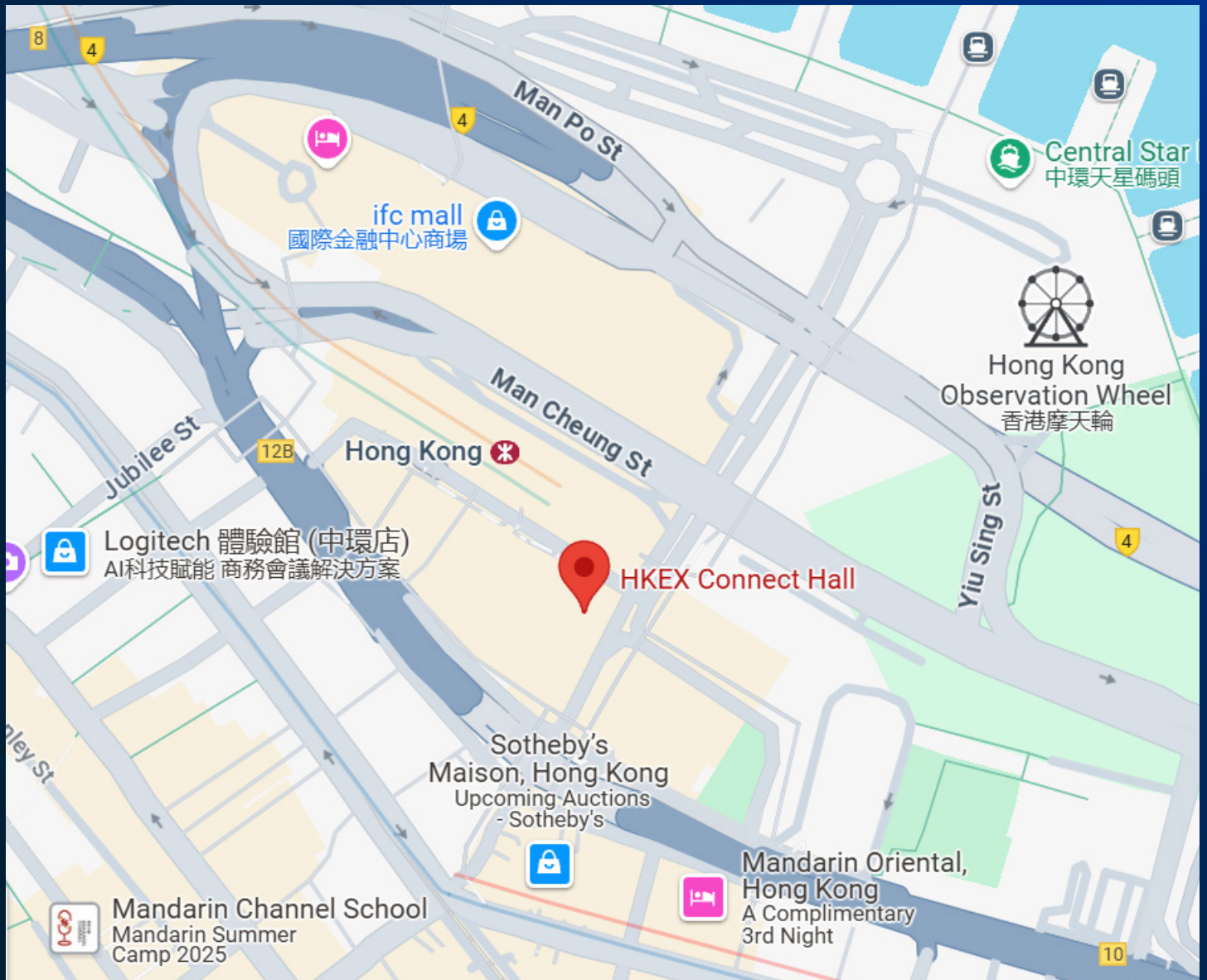

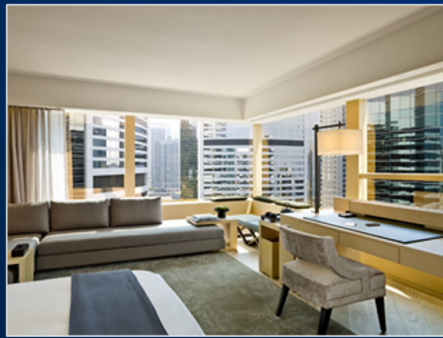
The Upper House
